Audiovisual Media Authority, AMA, after taking into consideration the issues of the agenda, approved the following decisions:

- 1. "Adopting the Strategy of the Audiovisual Media Authority and the Action Plan". (Decision no. 28, dated 29.03.2017)
- 2. "Approval of the Annual Balance Sheet of the Audiovisual Media Authority for 2016". (Decision no. 29, dated 29.03.2017)
- **3.** "Approval of the annual report of the Audiovisual Media Authority, for the activity developed during year 2016". (**Decision No. 30, dated 29.03.2017**)
- 4. "Accepting the request of the company "Media Content"sh.pk, deciding the suspension of the procedure for renewal of the license of the private local audiovisual subject "Tv A1 Report", its transfer to "Albanian News Television" company sh.p.k and the name change of the subject from "Tv A1 Report" to "Albanian News Television".
