Audiovisual Media Authority, AMA, after taking into consideration the issues of the agenda, approved the following decisions:

- Implementation of the decision of the First Instance Court of Tirana for the use of full numerical networks for the company "Klan" sh.a and "Top Channel" sh.a and the approval of the request of the company "Klan" sh.a (Decision No. 230, dated 03.11.2016)
- 2. Approval of the decision for opening the competition for the licensing of national networks and documentation application (Decision No. 231, dated 03.11.2016)
- 3. Approval of the amendment and amendment of the "Regulation on Procedures and Criteria for Issuing the Audio Broadcasting License" (Decision No. 232, dated 03.11.2016)
- **4.** Dismissal of the request of the company "BBF" sh.a., licensed to the private domestic audiovisual subject "Tv BBF" for the abolition of financial obligations for the period of suspension of the review of the request for renewal of the license (**Decision No. 233, dated 03.11 .2016**)
- 5. Replacement of the license of "UTV Education" sh.pk, licensed to the private local audiovisual subject "UTV Education", with license for audiovisual broadcasting and renewal of the license for audiovisual broadcasting with a deadline up to the date of the closure of the analogue broadcastings, in the licensing area of the private local audiovisual subject "UTV Education", with the same technical conditions as the existing license conditions (Decision No. 239, dated 03.11.2016).
- **6.** Expansion of the service provider area of "Vani" sh.pk, authorized for the repetition of audiovisual program service of the third-party audiovisual based on cable network "Tv Mati", in "Klos Administrative Unit" (**Decision No. 240, dated 03.11.2016**).

- 7. Renewal of the authorization of the subject Hajri Hoxha, for the repetition of audiovisual service programme of the third party based on cable network "HB-CA TV" (Decision No. 241, dated 03.11.2016).
- 8. Not renewing the authorization of the subject Dritan Xhaçi, licensed by the decision no. 21, dated 28.07.2010 of the KKRT, (today AMA) for the repetition of audiovisual service programe for the third-party based on cable network "Cable TV Xhaçi" (Decision No. 234, dated 03.11.2016)
- **9.** Refusal of appeal and leaving the decision no. 33, dated 15.09.2016, decided by the group of inspectors, at the amount of 2.000.000 (two million) ALL, towards the company "Arlibon" sh.pk, for the SMP subject "Tv Kabllor Fieri" (Decision No. 235, dated 03.11.2016)
- 10. Repeal of Decision no. 35, dated 22.09.2016 for the fine imposed by the group of inspectors, at the amount of 2,000,000 (two million) all, against the subject Mr. Dritan Xhaçi, for the SMP subject OSHMA "Cable Tv Xhaçi" (Decision No. 236, dated 03.11.2016).
- **11.** Repeal of Decision no. 36, dated 22.09.2016 on the fine imposed by the group of inspectors, at the amount of 2,000,000 (two million) all, against the Subject. Dritan Xhaçi, for the SMP subject "Cable TV Xhaçi" (Decision No. 237, dated 03.11.2016).
- **12.** Repeal of Decision no. 37, dated 23.09.2016, for a fine imposed by the inspection group at the amount of 2,000,000 (two million) ALL against the company "Tring TV" sh.a., for the numerical satellite platform "Tring TV" (**Decision No. 238, date 03.11.2016**)
- 13. Conclusion of the invalidation of the authorization of the subject Sulejman Leshi, for the repetition of audiovisual service program for the third-party based on cable network "Cable TV Lushnja", because of the expiration of the validity period and at the request of the subject for waiving the authorization (Decision No. 242, dated 03.11.2016)
