The scheduled meeting of the Audiovisual Media Authority (AMA) was held on Wednesday, 21 February 2018, with the participation of the following members:

Upon discussing the issues in the agenda, AMA decided as follows:

1. To grant the analog audio national broadcasting license to the “Club Muzikor” sh.a company, composed of the “Club FM Radio” audio programing service license and the license for the development and operation of the analog network that will cover the territory of the Republic of Albania with signal. **(Decision No. 26, dated 21.02.2018)**
2. To appoint Mrs. Vera Muço to the high level management position of Audiovisual Media Authority “Secretary General”. **(Decision No. 27, dated 21.02.2018)**
3. To determine audio broadcasting services frequencies for communities and to open the competition for the community audio broadcasting license. **(Decision No. 28, dated 21.02.2018)**
4. To open procedures for the granting of 16 private analog audio broadcasting licenses. **(Decision No. 29, dated 21.02.2018)**
5. To license the “TV Berati” audiovisual programing service and to transfer license rights of the subject from natural person Artur Shehu to natural person Alban Shehu. **(Decision No. 30, dated 21.02.2018)**

8. To license the “UTV Education” sh.p.k Company for the “Tv UTV Education” audiovisual programing service. **(Decision No. 33, dated 21.02.2018)**
9. To license the “Tv 5 Monde” sh.a Company for the “Tv 5” audiovisual programing rebroadcasting service. **(Decision No. 34, dated 21.02.2018)**
10. To revoke the authorization of natural person Bajram Akraqi, authorized to relay third party audiovisual programing services supported by the “Tv Kabllor Fier-Shegan” cable network. **(Decision No. 35, dated 21.02.2018)**
