The scheduled meeting of the Audiovisual Media Authority (AMA) was held on Friday, 13 July 2018, with the participation of the following members:

Upon discussing the issues in the agenda, AMA decided as follows:

- 1 To accept the request of the Autocephalous Orthodox Church of Albania to provide community audio services of the “Radio Ringjallja” subject in the Regions of Fier, Elbasan and Korça, and to narrow the service provision area of the subject in the Municipalities of Tirana, Kamza, Vora, Durrës and Shijak (**Decision No. 134, dated 13.07.2018**)
