COMPLAINT ON LICENSE OR
AUTHORIZATION¹

Complaint for:

- (AMA) Audiovisual Media Authority's decision on not granting a license/authorization for audio/audiovisual service
- AMA's decision on not renewing a license/authorization for audio/audiovisual service
- AMA's decision on revoking a license/authorization for audio/audiovisual service
- AMA's decision on the dismissal of an administrative appeal against the sanction adopted against the entity (citation/license suspension/authorization/ reduction of license/authorization term).

Invalidity/ revocation of license and/or authorization

Pursuant to law no. 97/2013, AMA has the authority to invalidate the license and/or authorization when:

- a) the term of validity expires, and it has not been renewed;
- b) the licensee or the authorized party notifies AMA in writing in reference to the cease of operations;
- c) AMA has issued a decision for license and/or authorization withdrawal based on the competences granted by this law;
- ç) bankruptcy is declared;
- d) the applicant does not withdraw the license and/or authorization or fails to meet the financial obligations provided for by law 90 days after the formal acknowledgment of its approval;
- dh) there is a final court decision prohibiting the exercise of activity by the licensee and/or the authorized party.

On the other hand, AMA has the authority to revoke a license and/or authorization when:

1. It was granted according to fake data presented in the application.
2. The conditions set out in the license are not met.
3. The financial obligations of the license have not been paid for a year.
4. There have been no broadcasts after the entry into force of the decision to issue a license for a time period of:
 - a) 6 months in local and regional audio broadcasts;
 - b) 9 months in the local and regional audio broadcasting service;
 - c) 12 months in the operation of the local and regional multiplex;
 - ç) 12 months in national audio broadcasts;
 - d) 18 months in the national audiovisual broadcasting service;
 - dh) 24 months in the operation of the national multiplex.
5. After broadcasting begins, during a calendar year, there are no broadcasts for 30 days, without taking into account disruptions due to technical reasons which are not dependent by the license holder.

1 The electronic submission of the complaint does not exclude the entity's obligation of filing a written administrative complaint and in fulfillment of the requirements envisaged by the Administrative Procedures Code.

6. There have been changes to the license holder that make it impossible to comply with the terms set out in the license.

7. The license holder's property, which directly serves to exercise audiovisual service activities, is on auction.

8. The subject is penalized more than 3 times within a calendar year with one of the legal sanctions.
