2. To approve the Instruction “On Program Format and Category for Recording and Archiving by Audiovisual Media Service Providers (AMSP). (**Decision No. 121, dated 08.06.2018**)
3. To revoke the “4 Plus Media Group” sh.p.k company license related to the private local audiovisual entity ‘Tv 4+’; (**Decision No. 122, dated 08.06.2018**)
4. To license the “Abc News” sh.a company for the “Tv ABC News” audiovisual programming service; (**Decision No. 123, dated 08.06.2018**)
