Upon reviewing the items of the agenda, AMA decided:

To accept the Autocephalous Orthodox Church of Albania request, for the community "Radio Ngjallja" radio entity to provide service in "Fier, Elbasan dhe Korça Regions", and reduce the entity's service provision area in "Tirana, Kamza, Vora, Durrës dhe Shijak Municipalities" (Decision no. 134, dated 13.07.2018)
