The scheduled meeting of the Audiovisual Media Authority (AMA) was held on Thursday, 08 October 2020, with the participation of the following members:

Upon discussing the agenda items, AMA decided to:

1. Determine 30 December 2020 as a deadline for switching to digital broadcasting in Kukës, Dibra and Gjirokastra regions. **(Decision No. 82, dated 08.10.2020)**
2. Approve some addenda and amendments to AMA Decision No. 183, dated 19.12.2019 “On the Adoption of the 2020 Draft Budget”, as amended. **(Decision No. 83, dated 08.10.2020)**
3. Deny the approval of the Draft Regulation “On Procedures and Criteria for granting Authorization to use HF Band Frequencies for Audio Service Provision”. **(Decision No. 84, dated 08.10.2020)**
4. Deny the approval of draft decision “On Amendments to AMA Decision No. 220, dated 01.12.2017 “On the Approval of Payments for License/Authorization and Services carried out by the Audiovisual Media Authority”. **(Decision No. 85, dated 08.10.2020)**
5. Determine the frequency of analog audio broadcasting service and open the competition for awarding analog audio broadcasting licenses. **(Decision No. 86, dated 08.10.2020)**
6. Open the competition for awarding 2 local licenses of general audiovisual program service in Tirana and Durrës regions. **(Decision No. 87, dated 08.10.2020)**
7. Renew the license of “Good News J-Media” sh.p.k. company, for the “Radio 7 Nord” private audio subject, and determine the subject service provision area from “*Shkodra and Vau i Dejës Municipalities*” to “*Shkodra and Vau i Dejës Municipalities and Koplík Administrative Unit*”. **(Decision No. 88, dated 08.10.2020)**
8. Transfer rights deriving from the natural person Orjana Cenko license, for analog audiovisual services “Tv Channel 7” to “Channel 7” sh.p.k.” company. **(Decision No. 89, dated 08.10.2020)**
9. Issue an authorization to “Selenice Kabllor” sh.p.k. company, for providing relay of third party audiovisual programming services supported by the “Selenicë Kabllor” cable subject. **(Decision No. 90, dated 08.10.2020)**

10. Renew the “Tata Junior” sh.p.k. company license, for third party audiovisual programming services relay, supported by the “Tv Kabllor Tata Junior” cable network. **(Decision No. 91, dated 08.10.2020)**
11. Reject the natural person Rahman Mekollari application, authorized to provide third party audiovisual programming services relay, supported by the “Tv Kabllor Kristal” cable network, on widening the service provision area to Librazhd administrative unit. **(Decision No. 92 dated 08.10.2020)**
12. Accept the request of the “Dynamicssound” company, licensed for “Radio One” audio subject, for the amendment of technical license conditions. **(Decision No. 93 dated 08.10.2020)**
