The scheduled meeting of the Audiovisual Media Authority (AMA) was held on Monday, 18 November 2019, with the participation of the following members:

Upon discussing the agenda items, AMA decided to:

1. Object the draft law “On some amendments and addenda to Law No. 97/2013, “On Audiovisual Media in the Republic of Albania”, as amended”. (**Decision No. 169, dated 18.11.2019**)
2. “Approve the changes that have taken place in the ownership structure of “RTV Adriamed” sh.p.k. company, licensed for the audiovisual subject “TV Adria Med” sh.p.k. and the audiovisual programming service name change from “TV Adria Med” to “Premium Channel”. (**Decision No. 170, dated 18.11.2019**)
3. Approve the request of “3DS &AF Entertainment” sh.p.k. company, to change the name of the audiovisual programming service from “TNT” to “Syri Tv”. (**Decision No. 171, dated 18.11.2019**)
4. Approve the request of “Focus Media News” sh.p.k. company, to change the name of the private audio programming service from radio “RASH” to “News 24”. (**Decision No. 172, dated 18.11.2019**)
5. Replace the license of “Channel One” sh.p.k. company, with an audiovisual programming service license for the Regions of Tirana, Durrës and Fier”. (**Decision No. 173, dated 18.11.2019**)
6. Renew the authorization of the natural person Pashk Laska, for third party audiovisual programming services relay supported by the “TV Kabllor Laçi” cable network. (**Decision No. 174, dated 18.11.2019**)
7. Reject the application of the natural person Erion Sefaj, to receive authorization for third party audiovisual programming services relay supported by “3ENET” cable network. (**Decision No. 175, dated 18.11.2019**)
8. Observe the invalidity of authorizing the natural person Sevi Mediu, authorized for third party audiovisual programming services relay supported by the “Tv Kabllor Anfab” cable network. (**Decision No. 176, dated 18.11.2019**)
9. **Accept** the administrative complaint of natural person Mr. Edi Tanushi and repeal decision no. 18, dated 15.10.2019, of the inspection group, with a fine in the amount of 1,000,000 ALL”. (**Decision No. 177, dated 18.11.2019**)

10. **Reject** the administrative complaint of “Beqaj Kabllor 2014” sh.p.k. company, authorized for the subject “Tv me kabëll Beqaj” and uphold decision no. 19, dated 15.10.2019, imposed by the Inspection Group in the amount of 1,000,000 ALL. **(Decision No. 178, dated 18.11.2019)**
