Upon discussing the agenda items, AMA decided to:

1. "Terminate analog broadcasting in the Regions of Tirana and Durrës on 01 October 2019 and postpone the deadline of switching to digital broadcasting in the Region of Vlora" (**Decision No. 119, dated 30.09.2019**)
2. "Open the procedure of granting 1 (one) local digital audiovisual broadcasting private license for the Region of Elbasan" (**Decision No. 120, dated 30.09.2019**)
3. "Grant a regional analog audio broadcasting license to "Radio Sol" sh.p.k. company, for "Radio Sol" audio subject, to cover with audio signal the Regions of Tirana and Durrës". (**Decision No. 121, dated 30.09.2019**)
