Following the review of the Articles in the agenda, AMA decided:

- 1 Approval of some amendments to AMA's Decision no. 11, dated 05.02.2021 "Approval of the guideline" On determining the rules of procedures for monitoring the election campaign coverage by audio/audiovisual media service provider (AAMSP)". (**Decision no. 05, dated 10.02.2022**)
- 2 Approval of an amendment to AMA's decision no. 97, dated 21.12.2021, "On the approval of the draft budget for 2022", as amended. (**Decision no. 06, dated 10.02.2022**)
- **3** Approval of the changes in the ownership structure of the company "RRTL-OTT", authorized to rebroadcast the audiovisual program of third parties based on the IP network (OTT) "RRTL-OTT". (**Decision no. 07, dated 10.02.2022**)
- **4** Acceptance of the request of the entity Elion Boriçi, natural person, authorized to rebroadcast the audiovisual program of third parties for "TV Kablo Brado" cable-based network and reduction of the service area of the entity within the territory of the "Administrative Unit Labinot-Fushë". (**Decision no. 08, dated 10.02.2022**)
- **5** Approval of the changes to the ownership structure of the company "MASA GRUP 2009" sh.p.k., authorized to rebroadcast the audiovisual program of third parties based on the cable network "TV Kabllor Masa Grup". (**Decision no. 09, dated 10.02.2022**)
- 6 Invalidity of the authorization of the company "Tema Tv" sh.p.k., regarding the provision of internet-based audiovisual program service "Tema Television". (**Decision no. 10, dated 10.02.2022**)
- 7 Invalidity of the license of the entity Thodhori Dukshi, natural person, regarding the local private audiovisual entity "TV Saranda" (**Decision no. 11, dated 10.02.2022**)
- **8** Invalidity of the license of the company "RTV-RE.AL" sh.p.k., regarding the local private audiovisual entity "TV RE.AL". (**Decision no. 12, dated 10.02.2022**)

In this meeting, AMA was introduced to the current commitment of the Authority for the monitoring of the election campaign coverage by Audio / Audiovisual Media Service Providers regarding the by-elections for mayor, dated March 06, 2022, in compliance with the obligations of the Electoral Code.
