Upon discussing the agenda items, AMA decided to:

1. Deny the local private audio broadcasting license to “Radio Televizioni Saranda” sh.p.k. company, for the “Saranda Ime Radio” audio subject. **(Decision No. 60, dated 21.08.2020).**
2. Deny the renewal of “ABC News” sh.a. company license, for the “ABC News” private audio subject. **(Decision No. 61, dated 21.08.2020).**
3. Renew the “Radio Logos” sh.p.k. company license, for the private local audio subject “Radio Logos”. **(Decision No. 62, dated 21.08.2020).**
4. Renew the license of the Embassy of France in Albania sh.p.k., for rebroadcasting the audio program “RFI” through a repeater, and reduce the service provision area. **(Decision No. 63, dated 21.08.2020).**
5. Renew the natural person Liberta Thanza authorization for third party audiovisual programming services relay supported by the “Tv Kabllor Drini” cable network. **(Decision No. 64, dated 21.08.2020).**
6. Renew the natural person Shpresa Boriçi authorization for third party audiovisual programming services relay supported by the “Tv Kabllor Tërbuf” cable network. **(Decision No. 65, dated 21.08.2020).**
7. Widen the service provision area for “Maqellara Tv Kabllor” sh.p.k. company, authorized to provide third party audiovisual programming services relay supported by the “Tv Kabllor Maqellara” cable network, in Gjorica Administrative Unit. **(Decision No. 66, dated 21.08.2020).**
8. Issue an authorization to “Tv Gold” sh.p.k. company, for providing online audiovisual programming services “Tv Gold”. **(Decision No. 67, dated 21.08.2020).**
9. Approve changes to the ownership structure of the “TEMA TV” sh.p.k company, licensed for audiovisual broadcasting. **68, dated 21.08.2020).**
10. Reject the administrative complaint of the natural person Preng Doda and uphold citation

decision No. 1, dated 21.07.2020, amounting to 2,000,000 ALL, imposed against subject “Tv me kabëll Besëlidhja”. **(Decision No. 69, dated 21.08.2020).** Page | 1
