Upon discussing the agenda items, AMA decided to:

"Postpone its decision making regarding the draft decision "On adopting the regulation "On procedures and requirements for awarding HF band frequency use authorizations, for audio service provision" and the draft decision "On some additions to AMA Decision No. 220, dated 01.12.2017 "On adopting fees for licenses/authorizations and services provided by the Audiovisual Media Authority". **(Decision No. 72, dated 03.09.2020)**
