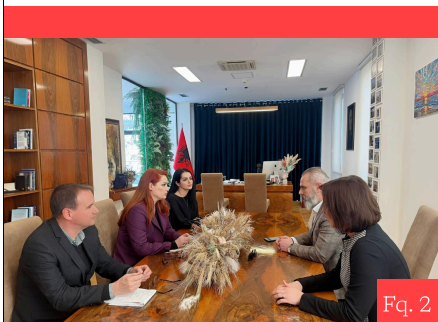

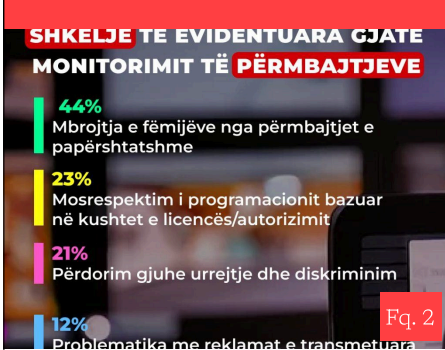

In her speech, Ms. Krasniqi stated that hate speech has become a global concern while presenting an overview of AMA's efforts in this regard. "We have worked based on several pillars: legal reforms, alignment with EU legislation and Western practices, respecting the Right to Information and Media Literacy for the public, which we

Of these, 220 were inspections targeting piracy, while 95 were on frequency monitoring. 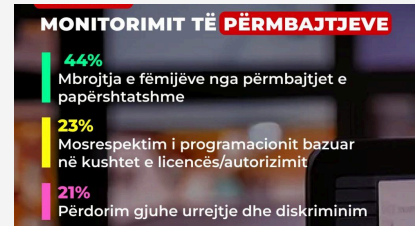

## Violations in audiovisual content: AMA reviews 241 cases

In 2024, a total of 241 cases of audiovisual content have been verified and reviewed for compliance with legal requirements and ethical standards. AMA's monitoring and content analysis teams have identified several types of violations, including: the protection of children from inappropriate content, non-compliance with pro-programming conditions as per license/authorization requirements, the use of hate speech and discrimination, etc.
