Albanian media and the disinformation phenomenon, a joint roundtable between AMA and "Faktoje" center

Albanian media and the disinformation phenomenon was the topic of a roundtable organized today by the Audiovisual Media Authority and "Faktoje" Center. According to the findings presented by the "Faktoje" Center, 60% of the journalists surveyed were unable to accurately define disinformation, while 100% of journalists working in online media admitted to publishing information without prior verification due to time pressure.
