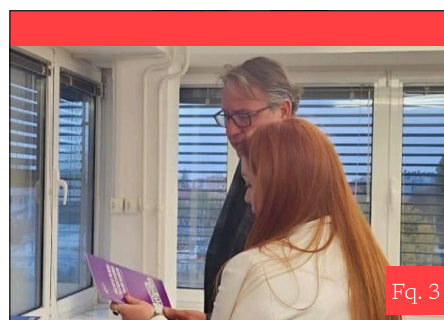

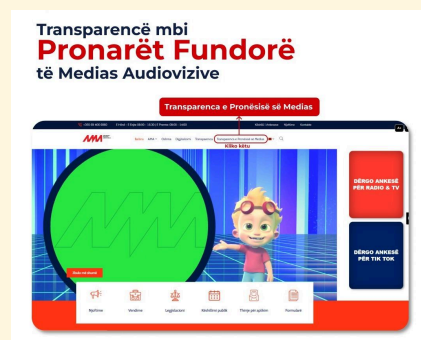


The 22nd Plenary Assembly of ERGA discusses the role of regulators in media monitoring
