

She provided several concrete suggestions regarding the Criminal Code draft, specifically on Articles 235, 267, 536, 863 and 865, while adding that she would like the new Criminal Code draft to provide greater special protection for journalists, media workers or flaggers.

## AMA – Platform X Transparency

### 22 pieces of content identified as law violations

A total of 41 pieces of content were reviewed by the public complaints assessment team for harmful content published on Platform X. Of these, 22 of them were identified as law violations and were reported through AMA's dedicated channel on the platform. Most of the complaints concern language exceeding moral and ethical standards, the incitement of violence and hatred, as well as the exposure of children to pornography, narcotics, alcohol and tobacco.
