AMA's Chair, Ms. Armela Krasniqi, has issued a statement today regarding the manner in which audiovisual media outlets have continued their on-site reporting following the grave incident that occurred at the Court of Appeals premises in Tirana, where Judge Astrit Kalaja was fatally shot. She announced that the day of the incident the Authority has issued 13 "Calls for Attention" to 13 television stations and has called for an immediate end to the broadcasting of messages that encourage violence.
