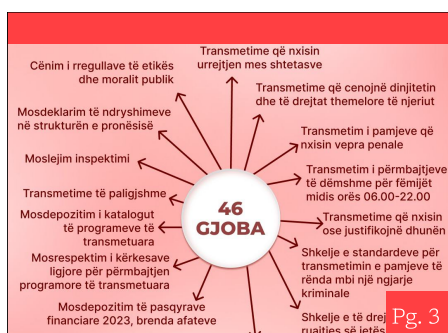

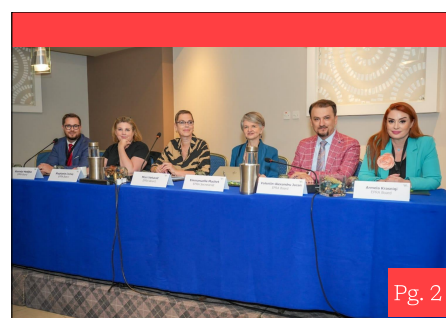

## The roundtable for the creation of the Digital Agenda, Krasniqi invited TikTok to cooperate with other Balkan regulators too

The creation of a Digital Agenda for children's safety in the Western Balkans was the focus of the first regional conference organized in Tirana by the Audiovisual Media Authority (AMA), in collaboration with the Center for Children's Rights in Albania (CRCA/ECPAT) and TikTok. Part of this roundtable were representatives from TikTok, regulators from Montenegro, Kosovo, and North Macedonia, field experts etc.

### The 60th EPRA meeting discusses the impact of Artificial Intelligence on media and the fight against harmful content

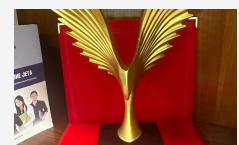

### In the fight against piracy, AMA teams do not stop blocking illegal platforms and identifying pirate servers



Continuous inspections by AMA teams, in collaboration with legitimate entities, have revealed the various methods lawbreakers use to steal audiovisual content without having any rights to it. In the Fier and Vlora districts, IPTV services were discovered, which were being accessed through the internal network of the public IP address, 109.236.45.14, via the portal <http://192.168.120.120:25461/c>. Meanwhile, in Saranda, two pirate platforms were shut down, and another OTT (Over-the-Top) server was identified, and it was accessible via all internet networks.



## Media Literacy, the excessive use of cell phones by children under 14 risks their health

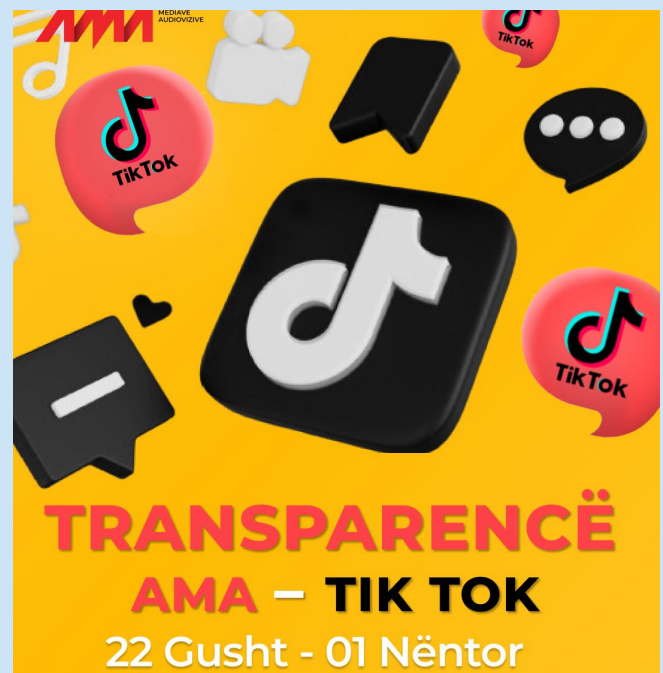

## AMA-TikTok transparency, all reported piracy videos removed from the platform

Since the beginning of the collaboration with TikTok, 995 videos reported for piracy have been flagged and also been removed from the platform. To date, AMA has reviewed and taken action on 516 complaints, with 178 of these found to be in violation of the law. Of those, 171 videos/audios have been removed from the platform, while 7 others are still under review.

## Law Violations: AMA issued 46 fines from January to October 2024

AMA issued 46 fines from January to October 2024. The penalties were directed at radio stations, television channels, and authorized cable providers for various law violations. Through content monitoring and the review of complaints received by the Complaints Council, the violations identified during this period included broadcasts that incited hatred among citizens, infringed on human dignity and fundamental rights, promoted or justified violence, etc.
