



At the Audiovisual Media Authority premises, a meeting was held with high level executives of audiovisual media service providers to consult on the draft law "On the release of Digital Dividend II (DD2) Frequencies". AMA's Chair, Ms. Armela Krasniqi, invited the operators affected by the release of the 700 MHz band, with the aim to harmonize spectrum use in line with European Union practices and the International Telecommunication Union (ITU) recommendations. Together with audiovisual media service providers' executives, the conditions of this transition were discussed, as set out in the draft law under public consultation.Read More
